#### 1. To discuss Revision of course curriculum:

Department of Physiology

- Minor adjustments in teaching and assessment methods will be implemented starting this academic year.
  - Department of Microbiology
- No syllabus or assessment revisions were made. Dr. Sheetal highlighted the need for better integration of microbiology with oral pathology to boost student interest. Dr. Deepa agreed on the importance of integration and requested submission of relevant topics at the earliest. Department of Pharmacology
- Dr. Torgal reported the commencement of integrated teaching on topics such as diabetes mellitus and hypertension. He also mentioned plans to cover dental emergencies and adverse drug reactions through hands-on experiences via cinemeducation and subsequent debriefing. Dr. Anand Patil suggested that these topics could be offered as electives. Department of Biochemistry
- Dr. Anil proposed replacing spotters with clinical scenarios to enhance integrated teaching. Department of Oral Pathology
- Dr. Deepa indicated that existing ITL modules already incorporate General Anatomy, Conservative Dentistry, Pedodontics, and Prosthodontics. They plan to implement rubrics for practical assessments and will add topics for the second year, including mucormycosis (as emphasized by DCI) and the influence of hormones on the developmental disturbances of Oral & Paraoral structures.

#### Department of Conservative Dentistry

• Dr. Anand Patil announced the introduction of composite restoration techniques in the preclinical second year, addressing patient preferences against amalgam fillings. External member Dr. Sumita supported this initiative and recommended including rubber placement training for second-year students using typhodont teeth.

#### **Additional Suggestions**

- Dr. Vidhi remarked that students often view Dental Materials as a dry subject. She emphasized the need for exposure to industry practices in the second year. She also suggested incorporating public health education from the first year to enhance students' understanding of marketing and financial management in the dental field. She emphasized the use of AI tools like ScanO for real time oral health screening and diagnostics.
- 2. To discuss the progress on the implementation of Electives for 1<sup>st</sup> and 2<sup>nd</sup> BDS students. Members to report on the E Content and mode of teaching
- Dr. Padmashri reported that Basic Life Support was conducted for first BDS students in the skills lab last year. Since this course serves as a value-added component for interns, department was advised to propose alternative elective topics. Histology Elective
- Dr. Shilpa mentioned that electives were not conducted last year but plans are underway to offer one on histology. Given its significance for dental students, they were urged to consider additional elective options.
- Dr. Sheetal noted that third-year MBBS students have a dedicated one-month period to complete electives in pre-paraclinical and clinical subjects, allowing the entire cohort to focus on electives simultaneously.
  - **Dental Materials Elective**
- A suggestion was made to revise and reframe the topic "Advances in Dental Biomaterials" to make it more specific. Dr. Santosh proposed an online teaching module followed by demonstrations when students visit the department, culminating in an MCQ assessment.
   Dental Ergonomics Elective
- Dr. Anand Patil outlined plans for the elective topic "Dental Ergonomics," developed in collaboration with the physiotherapy department. This will be delivered in a hybrid format, with online lectures and demonstrations conducted during practical sessions. Proposed Topics for Pharmacology Electives
- Dr. Anand Patil suggested "Prescription Writing" as an elective; however, Dr. Torgal noted that this is already covered in routine teaching. Members recommended including electives on "E-Prescription" and "Adverse Drug Reactions."
- Miss Siddhi, the student representative, noted that students find integrated teaching engaging and that it helps them better understand course material.

• Dr. Vidhi proposed the inclusion of various topics such as Geriatric Dentistry, Digital Dentistry, Tele Dentistry, and Sports Dentistry as electives. She also recommended incorporating Dental Law and Ethics, as well as Yoga for Dentists, into the curriculum.

#### Value-Added Courses

• Dr. Sumita suggested that basic self-defense training could be offered as a value-added course specifically for female students.

#### **Remedial Teaching**

Subject coordinators for first and second year were instructed to implement remedial teaching for the students who failed.

Dr Padmashri informed that they will be conducting integrated teaching with Pathology on the topic Bleeding disorders.

- Dr Shilpa informed that they will be conducting modified blended learning on the topics Muscular System with Physiology & Biochemistry and General Embryology with Development of face Integrated with Oral Pathology
- 4. Submit an Updated comprehensive panel of examiners UG, PG for Preclinical subjects approved and signed by the respective department heads and BOS members

Dr Chandra requested that departments to submit a panel of examiners, including a minimum of 30 names from both within and outside the state. Each submission should be accompanied by the signatures of the BOS member, the head of the department, the chairperson, the dean, and the director of academic affairs.

# Agenda for consideration (Starting of new courses, revision of course material, change in format of execution):

- 1. The members discussed newer teaching methodologies with a focused emphasis on clinical skills. Dr.Ramesh informed that department of Prosthodontics has planned for introduction of Role play for undergraduates that would enhance their communication skills. Dr. Vinayak informed that department of Periodontics would be introducing clinical tutorials with the focus on small group chairside demonstrations for undergraduates and table clinics for postgraduates. Dr. Manjula informed that department of Oral Pathology will be introducing the undergraduates with the application of binocular microscope.Dr.Aditi informed that Department of orthodontics shall be introducing flip class teaching and cephalometric analysis for undergraduates and dolphin software analysis for surgical cases, mini implant placement in the cadaveric lab and typhodont exercises for postgraduate students. Dr.Neha informed that the department of Conservative dentistry would be introducing table microscope in the preclinical exercises and table clinics for postgraduates. Dr.Kotrashetti informed that the department of OMFS would be using cadaveric lab for procedural demonstration and introduction of WhatsApp group for case discussion for the postgraduates. Dr.Roopali informed that the department of public health dentistry plans to introduce making of public awareness videos by the undergraduates and "read to lead" concept for the postgraduates. All the members were informed to make these changes as per curricular change guidelines and adept them into the time table planning of their respective departments.
- 2. The members discussed the current quota system for undergraduates and postgraduates in-force as per the DCI and KAHER guidelines and their stringent implementation. Dr.Sonal suggested if the ORION software could be used to quantify and match the patient quota completion with the revenue generated. Dr.Alka Kale suggested that there should be a significant weightage of marks given to the log book documentation of cases done by the students. Dr.Aditi informed that department of orthodontics intends to reduce the time required for completion of preclinical exercises for postgraduates from the existing 6 months to 3 months. Dr.Suresh suggested that monthly review meetings on quantum of work done should be conducted and those failing to meet the mandatory amount of clinical work to be done for the academic year should be detained from appearing for the university exams. Dr.Ballal suggested that guides should review the work done by their postgraduates and onward the same to the dean for

- necessary action in case any non-compliance is observed. It was also suggested that department of conservative dentistry set up an extraction protocol for teeth with a poor prognosis owing to cariogenic involvement.
- 3. POCO mapping presentation for the batch of undergraduates that appeared in July 2023 was done by Dr. Niraj. The attainment level set for the graduate attributes was achieved and was found to be satisfactory.
- 4. The members from department of Periodontics, prosthodontics and OMFS suggested that the certificate course in Oral implantology should be offered to external doctors other than those from the three constituent departments.
- 5. The members from all the streams of dentistry presented the electives in their specialties. The same was approved by the board and they have been asked to submit a hard copy of the same in the prescribed format within the next two days.
- 6. The proposal of dual degree program viz MDS along with PhD in the respective streams of dentistry was accepted by the board. Dr.Suresh informed the board that the same can be decided upon by the student within six months of admission to the Master of Dental Surgery. The dissertation topic select for MDS can be furthered into detail towards the PhD program. The other norms as per the KAHER guidelines towards admission in the PhD program shall be mandatory and binding on the candidate. No dilution in this regard shall be permitted. The board also resolved to further a requisition in this regard to the department of academic affairs for guidance in execution and implementation of the said program.
- 7. Dr.Badiger updated the board with regard to the current teaching program and evaluation protocols for undergraduate students in the discipline of General Medicine. The members suggested that a log book for documentation of case history recorded and there by evaluated should be maintained.
- 8. The members notified the board that there are no new proposals to start any new value added courses in their specialties.
- 9. The board took up for consideration the approval of one application received for recognition as Ph.D. guide/teacher. However since the applicant isn't a

PhD further clarification has been sought prior to approval from the department of academic affairs with regards to the existing UGC guidelines in this regard.

# Agenda for consideration (Starting of new courses, revision of course material, change in format of execution):

- 1. The board took up for consideration the approval of one application received for recognition as Pg guide/teacher. The applicant had fulfilled all the necessary requirement along with the documentation. The board members approved the application and the same is forwarded to the office of director, academic affairs.
- 2. Department of prosthodontics, orthodontics, periodontics and implantology, informed that they employ DOPS as a method of assessment for the students. (PG) Dept of pedodontics uses clinical case presentation as a method of teaching. Dept of oral surgery informed that they use case-based learning as a method of teaching. Dept of public health dentistry informed that they use field visits and research grant writing as newer methods of teaching. All the departments use flipped classroom and integrated teaching as a method of teaching.
- 3. It was informed by the director, academic affairs and Dr Vinayak Kumbhojkar, to update the question banks in the respective subjects according to the blueprint. Moderation of the question bank has to be done periodically by the subject experts.
- 4. The members discussed newer teaching methodologies with a focused emphasis on clinical skills. Dr Rajeev suggested use of smile designing technique to be incorporated as a method of teaching the undergraduates starting from 3<sup>rd</sup> BDS. Miss Divya suggested case-based learning exercise can be taught immediately after didactic lectures for the benefit of the students.
- 5. Dr Vinayak suggested to include composite restorations on the patients and amalgam restorations on typhodont teeth for training of students.

- 7. Dr Renuka informed about new binary manual of NAAC and various newer methods of teaching and assessment, out of which, problem-based learning and game-based learning would be taken up initially. The university would be conducting training programs for the teachers for these newer methods. The other methods of teaching and assessment would be taken up subsequently.
- 8. Dr Nandini informed about portfolio and open book exams as methods of assessment that can be employed for the students.
- 9. The members were informed to conduct interdisciplinary activities with various health and technology domains. Dr Renuka suggested to incorporate Indian knowledge system, mainly Ayurveda and Homeopathy, as a part of interdisciplinary activities to be conducted by all the departments with an emphasis on research for UG and PG

# PROCEEDINGS OF THE 55th MEETING OF THE <u>ACADEMIC COUNCIL</u> HELD IN THE ACADEMIC COUNCIL HALL OF THE KAHER ON <u>26-03-2024</u>

#### **MEMBERS PRESENT:**

(As per the Attendance Sheet)

Dr. M.S.Ganachari, Registrar and Member-Secretary welcomed the distinguished members and informed that the external members Dr. Sharath Kumar Rao K, Dr. Alladi Mohan, Dr. (Mrs.) Anura Bale and Dr. Shohan Chitlange have joined the meeting On-line. He informed that some of the members have sought leave of absence due to prescheduled engagements and the same was approved.

Dr. M.S.Ganachari informed about the sad demise of Dr. B. S. Kodkany, Former Professor of OBG and Former Director of KAHER Research Foundation on 22<sup>nd</sup> February 2024. He informed that he has rendered 60 years of selfless services to KLE, he was an inspiring Educator, Emeritus Professor, Teacher of Teachers, a great researcher and a distinguished academician with many awards of national and international repute including Dr. B. C. Roy award. The Members of the Academic Council observed one-minute silence as a mark of respect to the departed soul.

He requested the Chairman to chair and conduct the meeting as per the Agenda.

Hon. Vice-Chancellor welcomed and thanked the distinguished members for attending the meeting. He informed that Academic Council meeting was earlier scheduled on 21st March 2024. But as the UGC had called urgent meeting at New Delhi on 20-03-2024 to make presentation with regard to implementation of UGC Institutions Deemed-to-be-Universities Regulations, 2023 and NEP Policy-2020, the aforesaid meeting was rescheduled on 26th March 2024.

- The KAHER has appointed various statutory posts viz., Registrar, Deputy Registrars, Joint Controller of Examinations, Administrator and General Manager (KIIC). The services of the Finance Officer have been extended for one more year w.e.f. 1st January 2024. Dr. Pramod H. has been redesignated as Special Officer to Vice-Chancellor in cadre of Deputy Registrar.
- The KAHER has been recognized as Scientific and Industrial Research Organisation (SIRO) by Ministry of Science and Technology, Government of India on 4<sup>th</sup> December 2023. The institution can now avail custom duty exemption on the equipments procured for research activities.

 Dr. Richard Derman, Associate Provost for Global Affairs, Director of Global Health Researcher & Professor of OBG, Thomas Jefferson University, Philadelphia, USA is being conferred with Honorary Doctorate (D.Sc.) (Honoris Causa) by KAHER and the same will be awarded in the forthcoming 14<sup>th</sup> Convocation of KAHER.

 The KAHER has established the Department of Evidence Based Health Sciences and Dr. Mubhashir Angolkar, Professor & Head of Department of Public Health has been nominated as In-charge for the aforesaid department w.e.f. 1st March 2024. Hon. Vice-Chancellor requested Dr. Mubashir Angolkar to brief about the same.

Dr. Mubhashir Angolkar briefed about the establishment of the Department of Evidence Based Health Sciences and its long term and short term strategies that have been made. She informed that Hon. Vice-Chancellor has set a task of publishing 50 research papers per institute per year. For short term, it is decided to buy nested knowledge paid software and appoint four full-time staff which include two statisticians. These staff members will dedicatedly work towards writing research papers with all the constituent units. There will be KAHER Core Committee in which faculty from each constituent unit will be nominated as a Member, in turn a similar Committee at College level is to be constituted by the respective Principals.

She informed that the long term plan is to focus on training all staff members of constituent units in conducting systematic reviews. She informed that a network is being established with the Faculty from PGI Chandigarh, AFMC, Umea University and Thomas Jefferson University. India Cochrane is also collaborating with us for capacity building and hand holding activities for systematic reviews. In addition, mining of the hospital data for publications will also be undertaken. 15 faculty members of JNMC and KLE Homoeopathic Medical College and Ph.D. Scholars of KAHER are already getting trained with Umea University, Sweden for 'R' analysis and three students on qualitative research. These workshops will be repeatedly conducted to train more number of staff.

 Hon. Vice-Chancellor informed that KAHER has established Department of Digital Health and we plan to start Health Information Management Course. This course will be introduced from the academic year 2024-25. This is very unique course and run by only few institutions across the country and the people work

on digitalized health data. This course will be under Allied Health Sciences, and will be conducted in collaboration with Department of Master of Public Health and Master of Hospital Administration.
