


### Are the goals of the course curriculum clearly & explicitly stated?



















## General Insights:

1. For the first two questions ("Are the goals...?" and "Could you readily access...?"), the majority of responses cluster around 2, indicating moderate agreement or satisfaction.
2. For the other questions, the responses predominantly cluster around 4, showing strong agreement and satisfaction.
3. Variability is generally low, with a standard deviation below 0.4 for all questions, suggesting that most participants share a consistent viewpoint.
4. No responses fall into extreme disagreement (response 1) for questions with high means.



- The goals of the course curriculum were clearly and explicitly stated, with 99% of students responding "Yes" and 1% responding "No."
- The curriculum was readily accessible for reference, as indicated by 98% of students responding "Yes" and 2% responding "No."
- The curriculum suggested appropriate instructional materials, assessment processes, and learning resources, with 97% of students responding "Yes" and 3% responding "No."
- Students were made aware of syllabus planning/course syllabus at the beginning of the academic year, with 98% responding "Yes" and 2% responding "No."
- The instructional methods adopted by teachers were rated by students as follows: 66% agreed, 29% strongly agreed, 4% were neutral, 0% disagreed, and 1% strongly disagreed.

- The current curriculum promotes the development of clinical/laboratory skills, as rated by students: 63% agreed, 32% strongly agreed, 4% were neutral, 0% disagreed, and 1% strongly disagreed.
- The curriculum promotes interaction with peers, as well as the development of communication skills, ethics, and attitudes toward patients and relatives, with ratings as follows: 59% agreed, 34% strongly agreed, 5% were neutral, 1% disagreed, and 0% strongly disagreed.
- The curriculum encourages the development of leadership and teamwork qualities, with 61% of students agreeing, 34% strongly agreeing, 3% neutral, 2% disagreeing, and 1% strongly disagreeing.
- Formative (Internal Exams) and Summative (Annual Exams) assessments were conducted as per the course curriculum, as rated by students: 45% agreed, 54% strongly agreed, and 1% were neutral.
- Internal examinations were conducted regularly, with 42% of students agreeing and 58% strongly agreeing.
- Internal examinations helped in effective learning and acquisition of knowledge and skills, as rated by students: 50% agreed, 48% strongly agreed, and 2% were neutral.

Specifically, Students appreciated having easy access to the curriculum for reference purposes and were well-informed about syllabus planning and appreciated teachers' suggestions for instructional materials, assessment processes, and learning resources. The feedback also highlighted 56% of students strongly agreed that teachers effectively completed the curriculum within the academic year and conducted regular internal and annual examinations. About 56% of students strongly agreed that the instructional methods adopted by teachers were effective and the current curriculum was seen to promote the development of clinical/laboratory skills, leadership/teamwork qualities, ethics, and positive attitudes towards patients and relatives.

In the academic year 2023-24 students online feedback forms were prepared and filled by the students at the end of the session. In the introductory part of the form the students had to give their details about course opinion related to course content, relevance of the course, sufficient amount of reading material available in the college library and also about the methods of Internal assessment. Students have to rate their opinion in 5 point scale ranging from Strongly Disagree to Strongly Agree. 

















## Interpretation :

### 1. Overall Response Pattern:

- Most questions show a strong positive response, with a majority of participants giving a score of 5.
- Scores like 4 also appear in noticeable numbers, but scores below 4 (1, 2, or 3) are rare, indicating high satisfaction.

### 2. Key Observations:

- **Uniform High Scores:** Questions where scores are clustered tightly around 5 (and a small number at 4) indicate strong consensus and satisfaction with those aspects.
- **Low Variability:** Very few responses fall into lower categories (1–3), suggesting that most respondents did not express dissatisfaction.
- **Range Inclusion:** Even though the range of possible responses (1 to 5) was shown, many questions had zero counts for scores of 1 or 2, confirming overwhelmingly positive feedback.

### 3. Specific Insights:

- Questions related to content adequacy, infrastructure, or training typically had near-universal positive responses (5).
- Any question with a higher frequency of 4 scores relative to others could indicate areas of slight improvement, even though the overall sentiment remains positive.

#### 4. Areas for Focus:

- Since 5 dominates most questions, identifying specific questions where responses are less concentrated at 5 could highlight areas requiring further attention.

#### Conclusion:

The response distribution across all questions indicates a high level of satisfaction, with most scores concentrated at 5. There is limited dissatisfaction observed, as scores below 4 are minimal or absent. This reflects positively on the evaluated parameters but also suggests a need for focus on questions where scores are less concentrated at 5.


















### Ques 3: Modular distribution of syllabus


5. Are you aware of mentorship program in the institute?
