- It is feasible to train Community Health Workers
   (CHWs) to administer the Ages & Stages
   Questionnaires<sup>®</sup>, Third Edition (ASQ<sup>®</sup>-3) to screen
   for typical development or developmental delay
   (DD) in low resource settings, specifically in low- and
   middle-income countries (LMICs), resulting in timely
   access to early intervention.
- Predictive validity of the ASQ®-3 with the Bayley Scales of Infant and Toddler Development, Fourth Edition (Bayley"-4) was limited and requires further investigation.
- Nutrition, socioeconomic status, parental literacy, and birth weight positively influence the developmental trajectory of infants.
- The results of this study may also contribute to policy decision-making for using CHWs (ASHAs) for developmental monitoring of infants in low resource settings, specifically in LMICs.
