Echocardiography and Perfusion technology are courses involving clinical subjects and hence it is not possible to have a semester system. Semester system would result in piece meal learning and not continuous learning. These subjects require case discussion and dissertation and hence semester system is not feasible. Course coordinators of M.Sc. (Medical) subjects and B.Sc. Allied Courses said that they will be prepared to implement CGPA system during the next revision in 2023-24 and 2024 -25. Implementation of CGPA would require a lot of work and effort on the part of the faculty members and they would have to be properly trained in the same before it can be implemented

Discussion: This was discussed and deferred till March 2017 since PCI proposed new syllabus will be implemented from May 2017.


VIII) Fundamentals of Research Module

***PROCEEDINGS OF THE 52nd MEETING OF THE ACADEMIC COUNCIL HELD
IN THE ACADEMIC COUNCIL HALL OF THE KAHER ON 21st MARCH 2023***

MEMBERS PRESENT:

(As per the Attendance Sheet)

Dr. V.A.Kothiwale, Registrar and Member-Secretary welcomed all the distinguished members and introduced the external members (who were attending the meeting On-line) to the Chairman and requested the Chairman to chair and conduct the meeting as per the Agenda.

Hon. Vice-Chancellor welcomed the distinguished members and expressed that this is his first meeting of the Academic Council after he assumed charge as Vice-Chancellor and requested to continue to give their valuable guidance, co-operation and support to take the University to newer heights.

Hon. Vice-Chancellor briefed the members with the following information:

- The KAHER has to achieve higher ranking in the NIRF as well as better Grade in the NAAC in the coming years.
- The KAHER and its Constituent Units have good infrastructure, well equipped laboratories, faculty members, increase in the number of students admitted, library facilities, good performance of the students in their results, etc.
- The faculty members have to give more focus on the quality research / publications which are to be published in reputed and high impact journals.
- He observed that academic achievements deserve appreciation, but not the publications and research activities, as the publications and research activities are very less as compared to the number of faculty members working.
- The scope of thrust areas of research need to be widened Department-wise and specialty-wise.
- There is a need to continue the courses (which are recommended for discontinuation as there are no admissions for such courses) with Hybrid mode (Theory – Online and Practical – Off-line) as there are enquiries from the students for admission in case there is Hybrid mode of teaching.
- The KAHER is in the process of starting Extra-mural Certificate courses like, Awareness and Treatment on Breast Cancer, Organ donation, Kidney transplant, Heart transplant and CPR Skill under the Inter-disciplinary and Allied Health Science Courses.

Dr. V. A. Kothiwale, Registrar made presentation with regard to the important activities conducted by KAHER for the period from 19th October 2022 to 20th March 2023.

Dr. V. A. Kothiwale, Registrar informed that as per the guidelines issued by the UGC, the KAHER has constituted Research and Development Cell / Research Advisory Council in the month of October 2022 and under its five various committees are also constituted and they are conducting the activities as per the directions of the RDC/RAC.

Dr. Roopa Bellad, Director, Academic Affairs briefed with regard to the admission process initiated for Doctor of Philosophy (Ph.D.) program for the academic year 2023-24.

Reporting of other items for information:

Dr. N.S.Mahantashetti, Dean, Faculty of Medicine, informed the Academic Council that many Newer Teaching Learning methods have been implemented to the MBBS Phase I & II Students. Electives for MBBS CBME Batch are implemented from 13th March 2023.

Dean also informed that as per the recent guidelines of the National Medical Commission for the UG Curriculum, the Ophthalmology and ENT subjects have been included in the MBBS Phase III Part -II and the duration is revised to 17.5 months. This is applicable for the students admitted for the academic year 2022-2023. This is mainly revised for the purpose of preparing the students for exit examination. There will be two exit (NEXT) examinations one will be after MBBS Phase III Part II and another will be after the completion of Internship. In response to the same, Dr. Sharath Rao, distinguished external member reconfirmed the same. The marks obtained in the NEXT examination will be considered for PG entrance. The purpose is to make a single exam of All India Level Entrance for every medical student to appear which will make them align for FMG which requires not the University exam but a single All India Level exam for the medical graduates to be accepted as an International Medical Graduate.

Dr. Alladi Mohan, informed the Academic Council that the above revision is still not finalized (draft). The NMC has not come out with the exact format for MBBS Part I & II, whether to exclude / include the subjects, pattern of evaluation, adding MCQ's etc., no final Notification has been issued in this regard. At the same, the paper setters have received set of instructions given by NMC regarding how to set the question paper, MCQ's of various patterns which includes distractions, matching, statement, explanations and so on depending upon the teaching method.

Dr. Sonal Joshi, Dean, Faculty of Dentistry informed that there is a need to didactic lectures for Post Graduates as the Applied Science subject is taught early in the Graduate course and its prudent to revise the same to conduct the didactic lectures for the 1st year Postgraduate students. The students shall be taught in detail the applied aspects of the different basic sciences subjects by the Medical College faculty that has been mandated as a part of their PG curriculum. The same was discussed and recommended in the Faculty of Dentistry meeting held on 2nd March 2023.

The same was discussed and recommended in the Faculty of Dentistry meeting held on 2nd March 2023.

According to the Ordinance governing the Bachelor of Pharmacy, the lateral entry students have 52 credit points, whereas the regular Bachelor of Pharmacy have 56 credit points. Hence, in order to equate the credit points, the later entry students need to take up additional remedial topics / courses of Communication Skills (Theory & Practical) and Computer Applications in Pharmacy (Theory & Practical) equivalent to 2 credit points each (4 credit points) respectively so as to attain 56 credit points on par with the students of regular B.Pharm. students. The same was discussed in the meeting of Faculty of Pharmacy held on 8th March 2023 and recommended to place the matter before the Academic Council for further consideration.

Resolved to approve awarding additional four credit points for B. Pharmacy lateral entry students by completing prescribed courses with credit points so as to equate the same with the regular B.Pharm. students / course. 



Dr. Sharath Kumar Rao K, Dr. Alladi Mohan, Dr. Sohan S.Chitlange are attending the meeting On-line and requested the Chairman to chair and conduct the meeting as per the Agenda.

Hon. Vice-Chancellor welcomed the distinguished members and briefed the members with the following information:

- The KAHER has been focusing on research activities and publications for which various schemes have been introduced for financial grants to the faculty, students and research scholars to boost the research activities and publications.

Dr. M. S. Ganachari, Registrar made presentation with regard to the important activities conducted by KAHER for the period from 5th June 2023 to 23rd November 2023. He informed that KAHER has been granted with DSIR Certificate by Department of Scientific and Industrial Research (GoI) and 12B Status by University Grants Commission, which recognizes the KAHER for its higher standards of research. The grant of 12B status makes the faculty, students and research scholars eligible to receive grants from the University Grants Commission (Government of India) or any organization receiving funds from Central Government for conduct of various research and academic activities. This will provide significant boost for our research initiative and infrastructure development of the KAHER (University).

Hon. Vice-Chancellor informed that the KAHER has also applied to Scientific and Industrial Research Organization (SIRO) for certification so as to avail custom duty exemption on the equipments procured for research.

Ganachari, Registrar informed that the process has been initiated with regard to inclusion of new institutions viz., KLE JGMM Medical College and Hospital, Hubballi, KLE College of Physiotherapy, Hubballi and KLE Homoeopathic Medical College and Hospital, Belagavi under the ambit of KAHER through the Deemed-to-be-University Monitoring Portal (DTBUMP) for notification by the Government of India, Ministry of Education.

Reporting of admission process initiated for Doctor of Philosophy (Ph.D.) Program for the academic year 2023-24.

Dr. Sheetal Harakuni, Deputy Director representing Director, Academic Affairs made presentation with regard to the admission process initiated for Doctor of Philosophy (Ph.D.) program for the academic year 2023-24. The details are as follows:

Total applications received: 119

Total candidates appeared for Entrance Examination: 101

Total candidates passed in the entrance exam: 93 (92.08%)

In response to the clarifications sought by the distinguished members, Hon. Vice-Chancellor replied that:

- b. The candidates who have passed the Entrance Test conducted at National Level will be directly admitted to Ph.D. program.
- c. The KAHER considers payment of stipend to Full-Time Research Scholars by offering them JRF.
- d. The Half Yearly Progress Report submitted by the Research Scholars will be reviewed by the Doctrine Committee at the college level and 1st ,midterm and & 2nd open house by the Research Scientific Committee at the university

Dr. N.S.Mahantashetti, Dean, Faculty of Medicine and Principal, JNMC made presentation with regard to approval of starting of new academic programs / courses / curriculum as per the scope and demand and also taking into consideration the patient care in emergencies for the aforesaid programs / courses / curriculum.

She informed that Fellowship in Arthroplasty & Arthroscopy and Fellowship in Rheumatology have course duration of one year. Since we have no takers or less takers in the said courses it is decided to start the course in Hybrid mode with practical component Off-line.

The same was discussed and approved in the Faculty of Medicine Meeting held on 25th September 2023 and recommended for the same.

The Dean, Faculty of Medicine informed that starting of On-line Certificate Course in Geriatric Medicine and Gerontology has been postponed due to non-availability of Faculty for the said course. The external members suggested starting the course as an Inter-disciplinary Program with the involvement of faculty members from Dental, Ayurveda and other faculty as there is a good scope for the Geriatric Medicine and Gerontology. Hon. Vice-Chancellor suggested the Dean to report the same in the next meeting.

The Dean, Faculty of Medicine also informed that MSc. Clinical embryology which was approved to start in the previous academic council meeting will be started in the next academic year i.e., from 2024 onwards.

The dean informed that as per the Notification of Board of Ayurveda, NCISM the new implemented syllabus for the batch 2021 needs to be revised for every 5 years or until further notification from NCISM whichever is earlier. Accordingly, the BAMS – I & II Professional syllabus has been prepared and implemented from the academic year 2022 (Batch) onwards.

The Dean also informed that there is a need to start PG Diploma in Yoga Studies for the promoting positive healthy life style. The same was discussed and approved in the Faculty of Ayurveda Meeting held on 27th September 2023 and recommended for the same.



Background:

To arouse interest among medical undergraduate students and take one step more towards training budding surgeons of tomorrow, by early exposure to surgical Anatomy, we intend to implicate the surgical relevance of learning Human Anatomy. Hence, we propose an integrated value-added course from the department of Anatomy, with the Surgical specialties practicing various minimally invasive surgical procedures, at KLE's Dr.Prabhakar Kore Hospital and Medical Research Center, Belagavi, which is the need of the hour.

This is made possible by advances in Surgical education and practice, with the intention of better surgical management, with minimally invasive techniques and is preferred by surgeons and patients alike, due to the shorter hospital stay for the patients, early ambulation and faster recovery. By these techniques there is minimal alteration of normal Anatomy, at the same time doing the necessary surgical intervention, with great precision, successfully, by visualising the 3 Dimensional Surgical Anatomy on TV monitors and performing surgery through key holes. This definitely minimises the post-op complications of an open surgery.

The knowledge of Anatomy through key hole surgery as in Laparoscopy, or through Endoscopy by Natural Orifice Transluminal Endoscopic Surgery (NOTES) is required for the future aspiring surgeons, so an early orientation can be started while students are studying the normal Anatomy course itself, hence this value added course is put forth for approval.

We intend to target those enthusiastic Medical undergraduate students who have a keen interest in learning clinically relevant Anatomy, through early surgical exposure and to kindle their interest in pursuing surgical branches of Medicine in the future.

Objectives of the value added course:

- To be able to comprehend the different anatomical structures in an in-vivo setting
- To be able to know the relations of various anatomical structures through minimally invasive surgical approaches, by surgical VIDEO demonstrations, recorded from the High-Tech OT

Target group: MBBS undergraduate students with interest for pursuing surgical specialities in the future.

Benefits: students get to learn In-Vivo Anatomical orientation through minimally invasive approaches to surgical procedures, as an adjuvant to morphological and topographical relations of Gross Anatomy, learnt during dissection.

Course Duration: 16 hours

Teaching methods: there would be 7 sessions each session is planned for 2 hours duration. Lecture about the minimally invasive surgical procedure to be demonstrated by surgeons using video demonstrations for 1 and ½ hours followed by assessment, portfolio writing / log book writing for ½ an hour. The 8th session would be a practical hands-on workshop on surgical mannequins by at KLE's, Dr. Prabhakar Kore Clinical simulation center.

Materials: Pre-test, post-test, MCQ questionnaire, High-tech OT surgical video recordings, TV screens, Audio-visual aids, log book/ portfolio maintenance, perceptions by feedback questionnaire and reflection writing, resources for additional reading, hands on laparoscopic experience on surgical mannequins.

Methods: Clinicians most of whom would be surgeons from various specialities would conduct interactive teaching sessions and also explain with video demonstrations about Anatomical structures to be appreciated through minimally invasive surgical techniques and pathological findings and procedure performed.

Frequency of the course: to begin with ONCE a year

Total Participants: can enrol up-to 50 in a batch

Registration fees: Free, to begin with, for J. N. medical College students

The Dant Pari program was completed with an enrollment of four students and upon completion all the students have secured placements as chairside dental assistants in private dental clinics. The value-added course for the first year postgraduates was completed from 20-23rd February and was well appreciated by all the attendees. (**Enclosed are attendance details and feedbacks for both the courses**)

4. Dr.Anand Badvannavar updated on the completion of the first batch of the course of AI in dentistry with a strength of 16 students. **(Enclosed feedback analysis)**
5. Dr.Vinayak updated the board with regards to the proposals received from the departments of Prosthetics, Conservative dentistry, Oral surgery and Periodontics with regards to the training program for their post-graduates using the cadaveric lab. The evaluation shall be carried out and the same shall be incorporated in the postgraduate log books of the respective departments. It was suggested that a similar program be planned under the aegis of the department of oral implantology which can be taken up for discussion in the next BOS meeting. **(Enclosed details of programs submitted by respective departments)**
6. The members gave the feedback received on the curriculum at the department level, it was satisfactory. The central feedback mechanism evolved by the institute from various stake holders was taken up for information **(copy enclosed)**
7. All the departments except Oral surgery are currently having scheduled or completed interdisciplinary programs with other streams of health sciences of KAHER.
8. Results of post graduate part two examinations held in May 2023 were 100% in all the specialties.
9. The various departments have identified slow learners and fast learners as per the existing format and have undertaken remedial measures for slow learners and higher learning opportunities for fast learners respectively.
10. The panel of examiners has been updated as per the guidelines of the examination section of KAHER and shall be submitted within 4 working days after this BOS meet.

Agenda for consideration (Starting of new courses, revision of course material, change in format of execution):

1. Dr.Anand Badavannavar presented before the board a detailed outlay for changing the existing 6 month program on AI in dentistry to a one year certification program under certification of KAHER. The proposal was accepted by the board. **(Document proof enclosed).**
2. Dr.Hema Pangi made a detailed presentation with regards to changing the existing 6 months program of Laser applications in dentistry to a one year certificate program under certification from KAHER. The same was accepted by the board **(Document proof enclosed)**
3. It was resolved that an academic audit of the existing question banks should be carried out by all the departments to reaffirm the correct distribution of topics into; Must know, need to know and nice to know categories as well as deemed appropriate to be framed as a long essay or a short essay question categories so as to eliminate any ambiguity in setting and moderation of the question paper in the respective specialties **(Document proof enclosed).**
4. Dr.Neha proposed the inclusion of three new exercises to the preclinical teaching program for the post graduates of the department of Conservative dentistry and Endodontics. The same was accepted by the board **(Document proof enclosed)**
5. POCO matching with question paper and its analysis and observations thereof has been done upon completion of the final year examination of July 2023. Dr.Neeraj Gokhale has been asked to present a report of the same. It shall be taken up in the next BOS meet.
6. All the members presented the exercise, evaluation checklist and rubrics for assessment using DOPS. It was also suggested that student feedback and reflection should also be included. The same was approved by the BOS.
7. All the members submitted the list of slow and fast learners in their respective subject and the proposed steps to address the additional academic needs of both.

8. The board approved Dr. Deepa Mane Prof. Department of Oral Pathology & Microbiology, Dr. Siddhamesh Mutagi, Prof. Department of Oral & Maxillofacial Surgery and Dr. Rupali Sankeshwari, Prof. Department of Public Health Dentistry as Ph.D. guides and Dr. Sayed Killedar, Reader Department of prosthodontics as post graduate teacher. (**Applications enclosed**)
9. In any other matter the Board took up the discussion for starting a fellowship program in general dentistry. It was resolved the members get back to discuss the same with their respective departments and come back with proposals for the same at the next BOS meeting.
10. The Board unanimously accepted the proposal of a dual degree program that offers masters in dentistry followed by a post-doctoral degree for a combined period of five years in all the specialties of dentistry on lines similar to that proposed by the NMC. The guides for the two degrees of MDS and Ph.D. shall be as per the guidelines of DCI and KAHER respectively.

Agenda for information (implementation of previous resolutions, progress report, feedbacks):

1. BOS members Dr Vasudev Ballal, Dr. Niraj Gokhale and invitees Dr. Rekha expressed their inability to attend the meeting. They have communicated their inability via email to the competent authority through proper channel.
2. The minutes of the previous BOS meeting held on 11/02/2023 were read out and confirmed by the members present.
3. Dr. Vinayak updated the members with regards to the three new programs namely Dant Pari, Artificial intelligence in dentistry and value added course for first year postgraduates. The Dant Pari program was completed with an enrollment of four students and upon completion all the students have secured placements as chairside dental assistants in private dental clinics. The value-added course for the first year postgraduates was completed from 20-23rd February and was well appreciated by all the attendees. (**Enclosed are attendance details and feedbacks for both the courses**)

4. Dr.Anand Badvannavar updated on the completion of the first batch of the course of AI in dentistry with a strength of 16 students. **(Enclosed feedback analysis)**
5. Dr.Vinayak updated the board with regards to the proposals received from the departments of Prosthetics, Conservative dentistry, Oral surgery and Periodontics with regards to the training program for their post-graduates using the cadaveric lab. The evaluation shall be carried out and the same shall be incorporated in the postgraduate log books of the respective departments. It was suggested that a similar program be planned under the aegis of the department of oral implantology which can be taken up for discussion in the next BOS meeting. **(Enclosed details of programs submitted by respective departments)**
6. The members gave the feedback received on the curriculum at the department level, it was satisfactory. The central feedback mechanism evolved by the institute from various stake holders was taken up for information **(copy enclosed)**
7. All the departments except Oral surgery are currently having scheduled or completed interdisciplinary programs with other streams of health sciences of KAHER.
8. Results of post graduate part two examinations held in May 2023 were 100% in all the specialties.
9. The various departments have identified slow learners and fast learners as per the existing format and have undertaken remedial measures for slow learners and higher learning opportunities for fast learners respectively.
10. The panel of examiners has been updated as per the guidelines of the examination section of KAHER and shall be submitted within 4 working days after this BOS meet.
